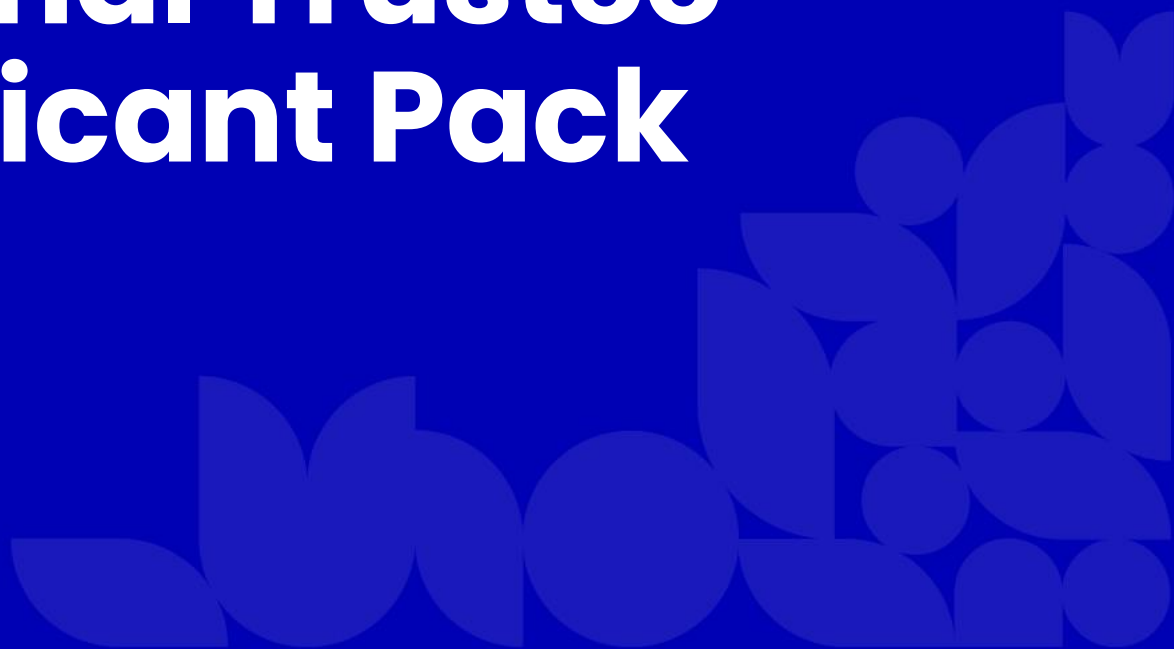

# What we do

At The SU Bath, our student leaders and elected representatives are supported by our professional and experienced SU Staff Team to create the opportunities that positively impact the local community.

Together we: Promote student interest and welfare; Provide support and advice; Represent the student community with the University and others; Provide social, cultural, sporting and recreational activities.

How we do this is through student-led:

- Voice – helping students stand up, speak up and make their voice heard,
- Experiences – making friends and memories that last a lifetime,
- Groups – broadening horizons with our communities of students,
- Support – providing advice and support on student life,
- Development – developing the skills students need to lead and change.



# Summary of the role



<b>Salary</b>	Voluntary role
<b>Duration</b>	3 year term
<b>Commitment</b>	The Board of Trustees normally meets four times a year. Needs to be available via email for urgent decisions that may arise outside of meetings
<b>Responsibility</b>	The Board is responsible for ensuring the organisation is fit for purpose. This involves approving the SU's annual budget, reviews policy and monitors organisational performance against agreed key performance indicators (KPIs).
<b>Location</b>	Board of Trustees meetings will be hybrid based at the University of Bath Claverton Down Campus
<b>Expenses</b>	The SU will reimburse you for expenses such as travel and accommodation following the relevant financial procedures.
<b>Support</b>	Training is provided to all new members to ensure the board is fully inducted and prepared to perform its duties.

# What our Trustees do

- Our Trustees are appointed for 3 years with the opportunity to stand for two terms.
- Provide The SU with a clear vision, mission and strategic direction. To do this our trustees are responsible for the performance and behaviour of the SU.
- Are responsible for the performance of The SU and ensuring that regulatory and legal requirements are adhered to.
- Act as guardians of The SU's assets, both tangible and intangible, taking due care of their security, deployment and proper application.
- Ensure that The SU's governance is of the highest possible standard.
- To hold the Chief Executive to account for the management and administration of the SU.



# Meetings our Trustees attend



## Board of Trustees:

- Four meetings a year with additional online meetings when deemed necessary.
- Meetings are hybrid with reasonable expenses reimbursed for trustees that do not live in Bath.
- Board of Trustees receive papers ahead of the meeting allowing them to prepare feedback and questions when the Board meets.



## Subcommittees:

External Trustees are invited to sit on at least one of the following Board subcommittees.

- **Finance and Audit Committee** oversees the financial and risk aspects of the organisation. Currently the Finance and Audit Committee meet 5 times a year.
- **Complaints and Disciplinary Committee** meets on a needs basis. It is called when an individual would like the outcome of an appeal reviewed. On average the committee is convened 3 times a year.

To ensure we have a well-informed board we particularly encourage applicants with knowledge in any of the following areas:

- Working across different communities
- Local knowledge and involvement in the City of Bath
- Equality, Diversity and Inclusion

We want our board to reflect the diversity of our students. We welcome applications from individuals of any background.
